AGREEMENT

The purpose of this Agreement is to provide consent and to exonerate MOUNT LAWN FUNERAL HOME & CEMETERY. (hereinafter "The Funeral Home") and VLC PRODUCTIONS INC. (hereinafter "The Live Streamer") of all liability for any actual or potential damages or costs arising out of a failure to deliver the live streaming service and/or hardware failure, software failure, negligence or another circumstances which may cause a disruption to the requested live streaming services and/or livestream recording.

I understand that the Funeral Home and The Live Streamer are not responsible in any way for the success of the delivery of the live streaming service.

I, therefore, release the Funeral Home, The Live Streamer, its related entities, directors, officers, administrators, managers, employees, representatives, agents and its livestream service provider (collectively the "Releasees") from all claims or potential claims in relation to the delivery of the requested live streaming services.

I waive all claims in this regard against the Releasees.

Furthermore, I undertake, as the Authorized Decision Maker, to indemnify and hold harmless the Releasees from and against any and all such claims, proceedings, liabilities, actions, damages, debts, or commitments whatsoever or any other demands brought by anyone with respect to any failures, loss, or damage sustained as a result of, or incurred by, the acts or omissions of The Funeral Home, The Live Streamer, or its third party live streaming services provider. I also, hereby, authorize and provide my consent for the Funeral Home and Live Streamer to provide my name, email address, and other relevant contact information to the live streaming service provider for the purpose of delivering the requested live streaming services.

TRAVEL AND TIME

A surcharge of \$100 per hour will be added for services that are fulfilled which are in excess of 4 hours total time. This includes the combination of the funeral, burial service, setup and take down. Additionally, any locations that are above fifty kilometres (50km) in distance from the location of Mount Lawn Funeral Home, will be billed at a rate of seventy cents (70¢) per kilometre (*above the first 50km in each direction*) and the total travel time will be added to the entire Funeral and Burial service(s) duration. Distance will be calculated based on the most direct route as recommended by Google Maps.

CANCELLATION

This Agreement outlines the terms between the Authorized Decision Maker, The Funeral Home and the Live Streamer, for services rendered. If the client cancels the services after the agreement is signed, a cancellation fee of 15% of the total contract value will be charged. This fee is intended to cover the Live Streamers time and any expenses incurred up to the point of cancellation.
